Overall Goal

To contribute to the effective promotion and protection of land and forest resource rights of ethnic minorities (EMs) in the northern provinces of Vietnam.



Objectives

Land Alliance (LANDA) member organisations and Commune Mediation Committees (CMCs) are resourced to support marginalised communities to claim their land and forest resource rights and to pro-actively participate in land governance processes.

Outcomes


- LANDA's members & CMCs dispose of an adapted toolkit (LRT) on land and forest resource rights of EMs;



LANDA's member organisations and CMCs dispose of an adapted toolkit on land and forest resource rights of EMs. Structure and composition of the toolkit developed and agreed by EMs, CMC, CBOs and LANDA members (Year 1)

16 LANDA member organisations, 3 well-known policy makers and researchers and 8 CMCs, 3 DoNREs are familiar with the toolkit (Year 2)

10,000 EMs (at least 40% women) are aware of the toolkit on land and forest resource rights (Year1,2 3)



LANDA member organisations and CMCs have strengthened capacities to support EMs to effectively claim their land and forest resource rights. Capacity gaps of LANDA members, LAs and CSOs are identified/prioritized (Year 1)

40 representatives of LANDA members have been trained on the prioritised topics (Year 2, 3)

150 key district/commune & community representatives (40% women) have been trained and coached by LANDA members (Year 2,3).

9 small grant initiatives (Year 2, 3).

LANDA member organisations and CMCs contribute to the formulation and monitoring of land and forest resource rights and related policy implementation. 6 piloting cases on land and forest resource rights of EMs documented by LANDA member organisations and CMCs (Year 2, 3).

8 multi-stakeholder dialogues conducted, 320 key reps of related gov. & non-gov agencies & local communities (40% women)

2 policy briefs are presented for consideration in policy making (Year 2, 3).

Access to land and forest resource rights-related information of local EMs is improved. 1 e-platform adapted to local contexts on land and forest resource rights is operational (Year1,2 3).

8 campaigns on land related rights are successfully organised (Year 3).

1000 visualized posters, booklets & multimedia products on land-related information from 6 best practices are distributed (Year1,2 3).

Introduce the toolkit to LANDA members, local CSOs, CMCs and related government bodies.	Year 1
Conduct awareness raising on civic participation and land-related rights at community level through use of the toolkit and communication campaigns by LANDA members and CMCs.	Year 1

Output 2: LANDA members and CMCs have strengthened capacities to support EMs to effectively claim their land and forest resource rights.

Elaborate capacity building need assessment of LANDA members, LAs and CSOs on land-related governance, conflict mediation and Year 1 negotiation, monitoring and methods for collecting evidence for policy recommendation.

Provide ToTs for LANDA members in cooperation with VLA on the identified topics.	Year 2, 3
LANDA members conduct training and coaching for CMCs and communities on related topics	Year 2, 3
Provide small grants for local communities' initiatives on practicing land-related rights.	Year 2, 3

Output 3: LANDA members and CMCs contribute to the formulation and monitoring of land and forest resource rights and related policy implementation.

Coach LANDA members and CMCs on gathering evidence & advocacy resources for policy dialogue and formulation of policy Year 2, 3 recommendations related to land governance at local and national level.

Support LANDA members and CMCs to engage with government authorities and private sector in policy formulation and implementation Year 2, 3 through multi-stakeholder platforms and other policy dialogue mechanisms.
